

## Fund Summary

### Investment Objective

The Rize Global Sustainable Infrastructure UCITS ETF (NFRA) seeks to invest in the foremost companies that potentially stand to benefit from the worldwide effort to support infrastructure development around the world in a way that balances economic, environmental and social objectives. These are companies involved in maintaining and upgrading the existing infrastructure of more industrialised economies, as well as companies developing new infrastructure required for the economic advancement of less industrialised economies. This includes companies involved in the development of the environmental and social infrastructure needed for our transition to a greener, fairer economy. The investment categories include (i) Transportation Infrastructure, (ii) Environmental Infrastructure, (iii) Data and Telecom Infrastructure; and (iv) Social Infrastructure. NFRA seeks to provide investment results that correspond generally to the price and yield performance, before fees and expenses, of the Foxyberry SMS Global Sustainable Infrastructure Index.



## Index Summary

### Index Description

The Foxyberry SMS Global Sustainable Infrastructure Index provides exposure to stocks of companies supporting global infrastructure development in a way that balances economic, environmental and social objectives. The index seeks to provide exposure to companies involved in maintaining and upgrading the existing infrastructure of more industrialised economies, as well as companies developing new infrastructure required for the economic advancement of less industrialised economies. This includes companies involved in the development of the environmental and social infrastructure needed for our transition to a greener, fairer economy. The investment categories of the index include (i) Transportation Infrastructure, (ii) Environmental Infrastructure, (iii) Data and Telecom Infrastructure; and (iv) Social Infrastructure. The index follows a low volatility screened, sustainability-based weighting scheme where companies with a higher sustainability score achieve a bigger weight in the index.










## Top 10 Countries

## Investment Team

### Investment Team


